- If you are a member of the Old Retirement System or the Contributory Pension System (Modified Teachers' and Employees' Pension System), your **retirement or pension contribution** appears in **Box 14** on your W-2 and is labeled as **STPICKUP**. This amount is excluded from your Federal wages reported in **Box 1** but is included in your State wages reported in **Box 16**.
- In **Box 12 a** through **d**:
 - Code C reports the value of the premium AACPS has paid for your *Group Term Life Insurance Coverage* over \$50,000.
 - Code DD reports cost of employer-sponsored healthcare.
 - Code E reports the total 403(b) contributions you made in 2015.
 - Code G reports the total 457(b) contributions you made in 2015.
- In addition to the retirement contributions described in 1, above, **Box 14** reports:
 - Healthcare insurance deductions
- Your contributions to the following, **formerly reported in Box 14** of your W-2, **can now be found on the last pay statement for 2015** (December 23, 2015 pay) or the last pay statement received if your employment ended prior to December 23, 2015.
 - Your contributions to a college savings (529) plan.
 - Your Long-Term Care insurance deductions.
 - Union dues.
