



Prekindergarten Application—Important Information

In order to enroll your child into Prekindergarten:

- Children must be four years of age on or before September 1st of the school year in which they are registering.
- Children must reside in Anne Arundel County.
- Public school prekindergarten programs in Maryland must serve children from economically disadvantaged or homeless families.
- If seats remain after all economically disadvantaged children have been enrolled, the system may enroll children who have other school readiness needs.

- Beginning February 6, 2019, applications for prekindergarten will be accepted at all prekindergarten program sites.

- You will need to bring the following documents with you when you apply:
 - Documentation of income eligibility for *Category 1* applicants only:
 - *Most recent Federal Income Tax Return (1040) or*
 - *A current Food Stamp Award Letter or*
 - *A current Temporary Cash Assistance Award Letter or*
 - *Proof of Foster Care income*
 - Your child's original birth certificate
 - A copy of your child's immunization record (Check immunization requirements at www.cdc.gov/vaccines/)
 - Proof of residency in Anne Arundel County
 - *Lease/mortgage document and a current telephone bill or utility bill or income tax/property tax notice or*
 - *A notarized Tenant Verification Form (available at all schools)*

Note: Homeless students have the right to enroll immediately

A current Federal Income Tax Return (1040) is required for Head Start enrollment
