Goals I hope to Accomplish if Appointed

- Work toward solving the compensation issues that have been a chief concern for several years.
- Foster policies and projects that make our schools and students safer.
- Increase public participation and strive for complete transparency in Board decisions.

Question #1

I am interested in serving on the Board of Education because I want to see the School continue to thrive and grow. Meaning that I believe the school system has been on a good trajectory for the last decade or so but along the way I have noticed that several times where the ball has been dropped so to speak. I believe that to have the best outcomes we need teachers and employees that are fairly compensated and enjoy their jobs. We need to solve the pay issues that have been plaguing us for some time now. In order to do that we need to take a careful assessment of our last few budgets and spending and see if there are places where we can find funding. In most of my previous jobs I been responsible for outcomes that hit the businesses bottom line, through P&L analysis. I look at the Profit and Loss statements to see trends and anomalies looking for places where money can be saved. One of my strengths is this type of analysis.

Over the last 17 years, I have advocated for the replacement or revitalization of several schools, served on redistricting committees, advocated for the growth of AVID, IB, MYP and other programs. I would push to continue this path of revitalization and smaller schools. I firmly believe that smaller class sizes will help us close the achievement gap and allow our students to achieve greater success. The Boards job is to establish and maintain goals for the Superintendent and monitor them for compliance. The systems new Strategic Goals need to be monitored to make sure that they are getting input from large representation of each school community.

I want to invest time into finding ways to make our schools and students safer, without turning the school into an environment that makes them uncomfortable. We need to consider the students entire path to school as well. How do we give students the skills to monitor and react to dangerous situations around them? These worries are manifesting themselves at an alarming pace, and we need to be proactive, not reactive.

Finally, I have heard from many parents that the Board Meetings are hard to attend that participation is limited and that decisions seem to be made privately and sometimes not in a transparent fashion. I would like to explore having meetings in other parts of the county and mainly at night to help working parents and citizens have a greater ability to attend.

Question #2

The most critical issues facing the school system are Teacher Compensation, a shortage of school psychologists and social workers, and class size.

It is no secret that fairly compensated teachers with reasonable class sizes and support from administration in the form of adequate ratios of students to psychologists, and social workers is a recipe for success. The problem, in my opinion, is that we do not always prioritize the classroom or student environment when budgets are created. I would like to see a bottom-up approach to classroom funding. Starting with a plan to get teachers and other employees back to a comparable salary to their peers in neighboring counties and then hiring enough teachers, aides, psychologists, and social workers to right size classrooms, especially at the elementary school level. Once those factors are set, we can build the rest of the budget by priority on what

is left, namely, safety, transportation, programs, and administration. We would need a tight partnership with the County Executive and County Council to achieve this. It must be a collaborative effort due to the limitations in revenue that Anne Arundel County has. We need to be frugal wherever possible and remember that as the county student population continues to grow so does its obligation to spend more, going beyond that structured increase is always tough.

From a statewide perspective, we are 7th from the bottom among counties in Maryland in perpupil funding. From a national perspective, the average per student is between \$11,000.00 and \$12,000.00 compared to Anne Arundel at just over \$14,200.00. Comparable counties are Montgomery and Howard, both at just over \$16,000.00 per student. I put this out there not to decry our ranking, but to give some perspective. We are a wealthy county that chooses to limit our taxes by law. It is the structure under which we must operate, to believe that we can drive our spending up without consequences in other departments is just not reasonable, the seat I am pursuing is only for 2 years, a ballot initiative to remove or change the tax cap cannot occur within that time frame. We can, however, put a measured agreement into place that builds teacher and administrative salaries by a percentage each year until we reach a level playing field. Losing teachers to neighboring jurisdictions is not an option, it takes continuity to build successful programs that raise achievement.

Question #3

I feel that the school system has several best practices. My perspective here is from many years of a strong PTA partnership with the school system. This partnership and the work of the Office of School and Family Partnerships is constantly ahead of its peers across the state. Fall and Spring Parenting Workshops and Presentations that help build up parental engagement and collaboration and celebrating volunteers over the course of the year and in May each year are two stellar examples of how the School System demonstrates it values parents.

I also believe that the new Strategic Goals being a school by school driven document will if utilized correctly by each school will be a real tool to energize communities and inform them about the school's practices and achievements. The three goals All Means All, Ready Set Launch, and Sound Stewardship are very encompassing and will build solid foundations for growth in our schools.

I continue to learn more about EEE, and I am encouraged to hear many teachers laud its innovative techniques. These techniques allow for some classroom flexibility and creativeness on the part of the teacher which benefits the different levels of learning encountered in today's classrooms. I have always been a vocal advocate for other special programs, AVID, IB, AP, MYP, and offerings like Project Lead the Way and STEM. While my children were in middle school, I was an AVID tutor; it was a very gratifying experience watching small groups tackle problems and pool their learning to teach each other, reinforcing the lessons in unique ways.

I would advocate as a board member for more vocational opportunities. A diverse offering of program choices helps students begin to narrow down tough life choices and provide varying degrees of rigor.

Question #4

My exposure to Anne Arundel County Public Schools has been rather extensive. I have been in a PTA leadership position for over 15 years. As County and State PTA President and in the years since I have conducted Leadership and Financial trainings several times per year. Met with principals and parent groups to start PTA's and help struggling PTA's. I have done many financial audits and personally trained several treasurers. I Served as Scholarship Chair and the Prom Breakfast Grants Coordinator.

I have served on the Parent Involvement Advisory Council (PIAC), Community Advisory Committee (CAC), Calendar Committee, as the Parent Representative on the Referrals Committee and several redistricting committees. I have testified before the Board of Education on numerous occasions and served for 2 years on the School Board Nominating Commission.

I have toured schools with the past Superintendent and helped arrange a visit by the former Secretary of Education Arne Duncan and the National PTA President. I have testified at the County Council on many occasions on the budget.
