ITEM 5.01 New Course Approvals

1. Members of the Board of Education, and Dr. Bedell:

I support the AP African American Studies course. Though, I must confess to a twinge of envy, as both this course and the LGBTQ Studies I proposed before this Board in February of 2022 are being offered after my time in AACPS.

However, that envy is eclipsed by my excitement for students to come who will benefit from courses that bridge gaps in our existing curriculum. Courses like this ensure that the stories and contributions of these groups are not relegated to the margins but are celebrated as an integral part of our shared history.

Though I am confident that the majority of this Board will vote in favor of this course, I feel compelled to address those who desire to follow the path that the state of Florida did in January of 2022 by prohibiting this course.

Let me be clear: your opposition to this course sends a damaging message to our students—that their history, their struggles, and their contributions are not worthy of in-depth study and understanding. In an era where knowledge is power, such a stance is not only regressive but dangerous.

Offering this course is an opportunity for AACPS to set a powerful example by demonstrating that education is not about erasing uncomfortable truths, but about confronting them, understanding them, and learning from them.

Thank you for your time and dedication to shaping an educational system that truly reflects the rich diversity and complexity of our society.
