

2022 *Secondary* *Summer School*

July 11 through August 11, 2022

The secondary summer school program offers students a limited number of secondary school courses and provides students the opportunity to:

- make up work in which they were unsuccessful.
- improve grade averages in sequential subjects.
- earn credits to meet high school graduation requirements.

Each course is highly concentrated and reviews the course content. Courses meet for two hours. All courses will have one-hour final assessments on the last day of summer school. There must be a minimum of 12 students enrolled in a course for it to be offered.

Secondary Summer School is a concentrated, fast-paced learning environment. Thus, learning profiles and differences should be examined carefully in the recommendation process as the goal is a successful engagement with performance outcomes.

Note: Summer School will operate Monday through Thursday from July 11– August 11, 2022. Schools are closed on Fridays.

About the Program

Secondary Summer School will be in-person for all courses.

The secondary summer school program offers courses for middle school and high school students. All high school courses may be taken **for remedial credit**. A limited number of courses may be taken for original credit. Middle school courses are limited to those students who have previously taken the course(s).

Remedial Credit: For high school students who have taken the course before and are repeating it in summer school.

Original Credit: A limited number of courses are available for high school students who have not taken the course.

Registration Procedures

Registration for AACPS students will take place on-line. Contact your school counselors for more information about the summer school registration process.

Note: *Please be aware that the entire Secondary Summer School Program is tentative. The actual summer program will be determined by the final budget approved by the county, sufficient student enrollments, and the availability of teachers.*

Credit to be Awarded

- 0.00 Middle school students needing classes for promotion or students interested in enrichment.
- 0.00 High school students needing to improve their letter grades or students interested in enrichment.
- 0.50 High school students repeating a half year course for which they have not received credit.
- 1.00 High school students repeating a full year course for which they have not received credit. Students **must** have passed one marking period in each semester of a full year course to qualify for one credit in summer school.

Program Policies

Admission

Summer classes are for students who are presently enrolled in an AACPS secondary school and who have been recommended by their home school principal or designee. Private school students and out-of-county students will be enrolled on a limited basis following registration of AACPS students. Bus transportation will be provided for AACPS students. Information will be provided when registering on-line.

Attendance

Students are required to attend the entire summer school session to qualify to take final assessments and receive a grade and/or credit. Students will NOT be excused for appointments, camp attendance, vacations, etc. Students must be in class at the time listed in this brochure. Repeated lateness to class will have disciplinary consequences.

Note: *A student who is absent more than one day from school, regardless of the cause(s) of absence, is excessively absent and may receive a failing grade and/or no credit for the course.*

Students must be present thru August 11, 2022, to meet all course requirements and receive credit.

Code of Student Conduct & Dress Regulations

Regular school rules, regulations, and dress requirements are in effect. The sale, use, or possession of tobacco in any form by students is prohibited in all school buildings and on school grounds at all times. This prohibition includes electronic cigarettes, smoking sticks, vape pens, and/or vape liquid, whether or not they contain tobacco products. Serious and/or repeated violations of school rules and regulations will result in a request for the student's removal from summer school.

Reports to Parents

Interim reports will be issued at mid-term to students who are not succeeding at a satisfactory level. Interim reports must be signed by the parent/guardian and returned to the teacher. Report cards will be mailed home one week after the conclusion of the summer school session.

Technology Resource Use by Students

AACPS is committed to providing safe and quality instructional opportunities for all students. The student is responsible for appropriate behavior while using technology-related resources. Teachers monitor student activities while online for appropriateness and instructional relevance. Rules and regulations designed to ensure proper use of technology include but are not limited to the following:

- plagiarize online content.
- create, access or distribute offensive, obscene, bullying, or inflammatory materials on AACPS technology-related resources or tools (including hardware, software, approved mobile devices, and websites).
- knowingly access unauthorized technology-related hardware and software to tamper with or destroy data.
- connect non-AACPS approved personal computing devices such as laptops or mobile devices to the AACPS network whether wired or wireless.
- use electronic or cloud-based resources and equipment in any other manner that would violate AACPS Board policies or state or federal laws.
- share user account information or passwords with others.

Directed Internet Use

- Requires appropriate adult supervision. (i.e., staff members or their adult designees must be present to actively monitor student access to the Internet).
- Internet searches will be conducted using AACPS recommended search engines, online databases, and sites.
- Students may not type in web site addresses (URLS). (Exception: High School students with active supervision of an adult and in compliance with the above stated conditions).
- Internet use is permitted at all levels and in compliance with above stated conditions.

Summer School Fees

AACPS students: No charge

In-county private school students: \$300 per course/class period

Out of county students: \$600 per course/class period

Payment in full is required at the time of registration. ***Partial payments will not be accepted.*** Payments can be made by personal check, money order, or certified check. Please make payable to ***Anne Arundel County Public Schools.*** The check or money order should have the name of the student printed on it. Checks returned because of insufficient funds may result in the student's withdrawal from summer school and grades and/or credits being withheld. A \$35 fee is charged for returned checks.
