We hope you were able to spend this Valentine's Day with somebody special! Our winter has been cold and snowy –especially compared to the last few years. So, if you are ready for some warmer weather, think about joining us in sunny Florida for our 26th "Get Together!" Our thanks to Barbara Zelle and Kim Proctor for hosting this event in Sarasota, March 9 and 10.

Dr. George Arlotto, Superintendent of AACPS, joined our Executive Board meeting via Zoom on January 13. He shared that the school system was short 60 teachers at the beginning of the year, and that number has now grown to 90. We asked how, as retired educators, we could help. He suggested that we might assist as mentors and volunteers. He is directing his staff to draft a proposal for our membership.

We are looking forward to the February 10th Luncheon and General Membership Meeting at the Blue Dolphin Restaurant in Gambrills. Guests include Wanda Twigg, Executive Director of MRSPA, and Joe Maddalon, a representative of the Association of Member Benefits Advisors (AMBA). In recognition of Black History Month, Program Chairperson Dixie Stack, has made arrangements for a presentation by Vincent Leggett on Carr's, Sparrow's and Elktonia Beaches, African

American venues which flourished in Annapolis from the 1930's to the 1970's.

Under the leadership of Susan Baugher, the Pre-Retirement Committee is working to create a new brochure to be given to potential retirees. The brochure will contain information about the work and benefits of AARSPA and MRSPA in hopes of building our membership.

Due to generous contributions in memory and in honor of individuals, successful fundraising dinners, and 50/50 raffles at luncheons, AARSPA will be awarding four scholarships this year. The Scholarship Committee will soon be reviewing the applications. Anyone interested in joining this committee should contact Tillie Barckley.

The Membership Committee has proposed that we reach out to our Eastern Shore and Delaware members and is interested in organizing a special event in 2023. Although the event will be open to all AARSPA members, it is being planned with the Eastern Shore folks in mind, and an interest survey is being sent to those living east of the Bay Bridge.

The MRSPA Legislative Workshop was held on January 26. Of the sixty statewide participants, seven were members of AARSPA. Several

presentations were made regarding the state budget, our pension system, current legislation being considered, and MRSPA legislative priorities.

Some good news! The pension system is currently funded at 76.9% and the Pension Board has reduced the assumed rate of return from 7.4% to 6.8% effective July 1, 2022. It was emphasized that it is important to maintain our defined benefit pension. Martin Noven, Executive Director of the Maryland State Retirement and Pension System, stated that we are well positioned to hit 80% funding by 2026.

We want to thank all of our officers, chairpersons, and committee members for the time and effort that they give to keep our organization afloat. We are always looking for new ideas and an extra pair of hands to do the work of AARSPA. Please consider getting involved!

8. Bring firewood into the classroom for the stove whenever the teacher tells you to.
9. Go quietly in and out of the classroom.
10. If the master calls your name after class, straighten the benches and tables. Sweep the room, dust, leaving everything tidy,

# Legislative Update

The new legislative session is now underway, having started on January 12<sup>th</sup>. There are 220 Senate bills and 200 House bills prefiled with topics including election laws, long term care, Alzheimer's and Dementia services, consumer protection, prescription drugs, guns, tenant rights, energy conservation, etc. Our very own AARSPA member Virginia Crespo, is the state MRSPA Legislative Aide, and she is closely monitoring the bills throughout the session.

Our pension system is doing very well as is our state's economy under our current tax rates. We have top hospitals, biotech research facilities, defense contractors and the federal government in our backyard. As seniors, our first \$30,000 of income from pensions and 401(k) or 403(b) accounts, are excluded from state taxation. Thanks to federal generosity, our legislators will now be guiding our budget surplus. In the past, surpluses have been handled by awarding immediate tax rebates, helping fund education reform, ensuring Maryland's future in this highly technical economy, etc. ...not with cutting taxes that result in long-term deficits, reduction in services which we all enjoy now, and inevitable raising of taxes to back where they were before any permanent \$billion tax cut.

Our state association, MRSPA, advocates for its almost 14,000 members and works to protect defined benefit pensions and a secure retirement for all Marylanders. The priorities for this year include **Pension Protection, Safety, Consumer Protection, Health Care, Technology, Quality of Life, Long Term Care and Education.**

MRSPA recently held their Legislative Workshop virtually and many of our AARSPA members attended. Topics included:

- Maryland Budget Overview by Rebecca Ruff, Operating Budget Manger, Department of Legislative Services
- State Retirement and Pension System Update by Martin Noven, Executive Director, Maryland State Retirement and Pension System
- NRTA Legislative Priorities and Other State Pension Attacks by Adam Goldberg, Senior Legislative Representative, National Retired Teachers Association/AARP
- AARP MD Legislative Priorities by Tammy Bresnahan, Associate state Director Advocacy, AARP
- MRSPA Legislative Priorities and Updates by Virginia Crespo, MRSPA Legislative Aide

## From AARP—The Ten Worst Things to Carry In Your Wallet

These items are better stored in a fireproof lock box, or a safe deposit box depending on how often you need to access them:

- Social Security card
- Covid-19 Vaccination Record card (which carries your date of birth and hints at where you live)
- Multiple credit cards and credit card receipts
- Checkbook, or even one blank check
- Work ID card
- Passport or passport card
- List of your passwords
- Gift card not fully redeemed
- Birth certificate
- Library card (it sounds benign, but a thief can check out lots of books and sell them for a buck or two apiece)

## Did you lose your Vaccine Card?

- Check and see if your vaccine provider, be it a retailer pharmacy or health department allows you to access your vaccine records online.
- Call the pharmacy or location where you were vaccinated and request a duplicate record.
- Check your email. If you signed up for your shot online and provided an email address, a vaccine record is automatically sent to that address post-vaccination.
- If you want the actual, physical card issued by the CDC, you may need to contact your state health department, either by phone or email.
