

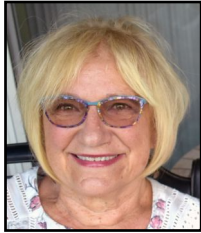

On behalf of AARSPA, we would like to congratulate and welcome our new superintendent, Dr. Mark Bedell. He comes to us after serving as Superintendent of Kansas City Public Schools from 2016-2022, where he had a very successful tenure. No stranger to Anne Arundel County, Dr. Bedell lived here when he was an assistant superintendent for Baltimore County Public Schools. We are looking forward to developing a positive and strong relationship with Dr. Bedell.

On September 15th we held our General Membership Meeting/Luncheon at Kurtz's Beach with approximately 75 people in attendance. The highlight of the meeting was a presentation by Bridgett Wicklein, Benefits Manager for AACPS, and Carla Thomas, Retirement Coordinator for AACPS. They shared information regarding our health care benefits for 2023. Rather than a benefits booklet, retirees will receive a letter outlining rate increases for the coming year. Booklets will still be available upon request from the Benefits Office. Open enrollment for those wishing to make changes is October 17-28, 2022, but no action is necessary for those not wanting to change their coverage. Great

news—the rate increase for our medical insurance for 2023 is 2 percent.

In addition, those present at the meeting received updates from various committees, were served a delicious lunch, and were provided with entertainment by "Two Cool Dudes." Thanks to the generosity of our members, we collected many school supplies at our meeting. A "thank you" goes to Phyllis Cherry for delivering those items to Hilltop Elementary and Mills-Parole Elementary.

Our next membership meeting will be held at Renditions Golf Course in Davidsonville on Thursday, November 10th. The Community Service Committee will be collecting non-perishable food items to be donated to the Anne Arundel County Food Bank and pet supplies for the Anne Arundel County Animal Care and Control.

Due to a decision made by Scholarships for Scholars, our AARSPA scholarships for high school seniors planning to become educators have been raised to \$5000 each. We hope to be able to continue to support four scholarships. Tillie Barckley, scholarship chairperson, has made arrangements for another fundraiser at the Killarney House in Davidsonville for November 29, 2022. Thanks to our members for your fundraiser support and your generous contributions.

National Prescription Drug Take-Back Day Saturday, October 29, 2022

Over 700,000 pounds of drugs were turned in on the last Take-Back Day in the U.S., which was held on May 23, 2022!! Getting un-used prescription drugs out of your home helps everyone! Since COVID-19 upended day-to-day life for Americans in March 2020, public health officials have been sounding the alarm about a potential surge in drug overdoses. Getting those drugs out of the home is a great way to help. If you're not sure where your location is, check out www.dea.gov for locations near you. Many local police stations offer everyday collection. Check the one in your area.

Tips For Safe Fall Driving

Every year, thousands of people are injured and hundreds of people are killed due to daylight savings time changes and the change of seasons. Daylight savings ends on November 6th—days will be getting shorter.

Autumn means we need to be more careful as drivers.

Weather—Sudden changes in temperature, rain, snow and fog all make for hazardous driving. Be aware of the weather—know before you go.

Sunrise and Sunset—Daylight Savings Time means the sun on the morning drive might be right in your eyes. The sun goes down early in the fall so it gets dark a lot sooner—**HEADLIGHTS!!**

Children — Children are heading back to school. Be aware of walkers and observe crossing guards. Remember school bus safety and never pass a stopped bus. The law says it is illegal—and very dangerous—to pass a stopped bus when the large red lights located on the top of the bus are flashing. Flashing lights or STOP signs on the bus means the bus is picking up or discharging students. You must stop whether you are approaching the school bus from the front or overtaking it from the rear.

Animals are preparing for winter—be wary of them—especially deer!!

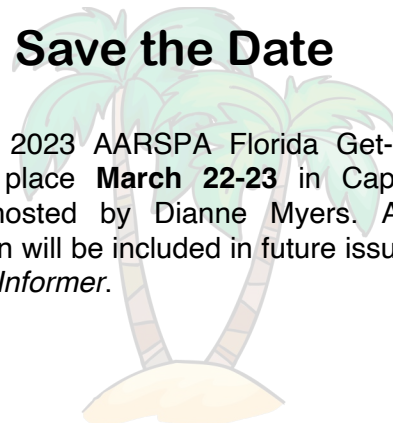

Why are seniors targeted?

1. We are home during the day and answer the phone.
2. We are polite and less likely to hang-up.
3. Many are lonely and want the talk to someone.
4. We are trusting.
5. We are less technically savvy.
6. We have more financial resources.
7. We are more intimidated when pressured.
8. We are less likely to report it.

While it may take awhile for a scammer to get caught, the police are working constantly to catch them. However, catching them only happens when you report it to the police. Check out the Anne Arundel County police website. They report the latest scams in the area and who has been arrested.

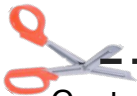
